FINAL MOTORCITY CASINO HOTEL'S "HOT DOG EATING CONTEST" OFFICIAL RULES, ACKNOWLEDGEMENT AND RELEASE

Each individual who participates or attempts (in any way) to participate in the Oualifying Game (as defined below) will be deemed to have read, understood, and agreed to the Official Rules for the "Hot Dog Eating Contest" set forth below. Each individual who signs this document will be deemed to have acknowledged that he/she has read, understood, and agreed to the acknowledgement and release language contained in this document.

The Official Rules ("Rules") for MotorCity Casino Hotel's "Hot Dog Eating Contest" (the "Contest") are as follows:

- 1. DETROIT ENTERTAINMENT, L.L.C. d/b/a MOTORCITY CASINO HOTEL ("MOTORCITY CASINO HOTEL") RESERVES THE RIGHT, IN ITS SOLE DISCRETION, AT ANY TIME, FOR ANY REASON OR NO REASON, AND WITHOUT PRIOR NOTICE TO ANYONE, TO SUSPEND, CANCEL, OR MODIFY, IN WHOLE OR PART, THE CONTEST, AND/OR ANY PROVISION OF THE RULES. The immediately preceding sentence is deemed to be incorporated into and to be in immediate conjunction with every provision of the Rules. NO ENTRY FEES WILL BE CHARGED FOR PARTICIPATION IN THE CONTEST.
- The Contest will occur on February 19, 2013 ("Contest Day") at MotorCity Casino Hotel's Sound Board theater located at 2901 Grand River Avenue in Detroit, Michigan ("Sound Board"), beginning at the Contest Time (as defined in Rule 3 below). The Contest will consist of a Qualifying Game (as defined below) and Hot Dog Eating Contest (with each reference to the Contest in these Rules, Acknowledgement and Release being deemed to refer to both the Qualifying Game and the Hot Dog Eating Contest, unless otherwise indicated). Individuals who desire to have an opportunity to participate in the Contest must: be 21 years of age or older as of the date of the Contest; satisfy all other eligibility requirements set forth in these Rules; carefully review these Official Rules, Acknowledgement, and Release ("Required Documentation"); and, in the case of selection for participation in the Hot Dog Eating Contest, sign the Required Documentation and return it to MotorCity Casino Hotel (to the attention of such personnel as MotorCity Casino Hotel designates prior to commencement of the Hot Dog Eating Contest) prior to the commencement of the Hot Dog Eating Contest (collectively, the "Eligibility Requirements"). In connection with satisfying the Eligibility Requirements, each individual will be required, on one or more occasion(s), to present to the Contest Representative (as defined below) his/her current and valid driver's license or other government-issued identification card acceptable to the Contest Representative in his/her sole discretion ("Government ID"). Only those individuals who meet and timely comply with each of the above-stated Eligibility Requirements will be permitted to have an opportunity to participate in the Contest. Failure to comply with any of the Eligibility Requirements will result in forfeiture of the right to participate in the Contest and to receive a Prize (as defined below).
- 3. The Qualifying Game: Successful completion (as detailed below) of the Qualifying Game is a pre-requisite to participation in the Hot Dog Eating Contest. Individuals desiring to participate in the Qualifying Game must be present at Sound Board on the Contest Day at the "Contest Time" (meaning such time as MotorCity Casino Hotel designates prior to and/or on the Contest Day by verbal and/or written notice at its casino complex and/or on www.motorcitycasino.com and/or www.soundboarddetroit.com) and must satisfy all Eligibility Requirements; each individual satisfying those requirements will be deemed a "Potential Contestant." During the Qualifying Game, the "Contest Representative" (meaning such employee or agent of MotorCity Casino Hotel as it designates in its sole discretion) will ask the Potential Contestants a maximum of twenty (20) skill-based trivia questions ("Trivia Questions") selected by MotorCity Casino Hotel in its sole

discretion. After each Trivia Question is asked, the first Potential Contestant to raise his/her hand in response (as determined by the Contest Representative in his/her sole discretion) will be allowed to answer that Trivia Question. If the selected Potential Contestant correctly answers the Trivia Question, then he/she will be a contestant in the Hot Dog Eating Contest, provided he/she meets all of the Eligibility Requirements and is not otherwise prohibited or disqualified from participating in the Contest (each a "Contestant"). If the Potential Contestant answers incorrectly, the Trivia Question will be posed again, and the remaining Potential Contestants will have the opportunity to answer it, pursuant to the above-described selection process, which process will be repeated until a Potential Contestant correctly answers that Trivia Question or the Contest Representative, in his/her sole discretion, elects to ask a different Trivia Question. The Contest Representative will continue to ask Trivia Questions and the above-described process will be repeated until the total number of Potential Contestants who have correctly answered a Trivia Question and otherwise met the Eligibility Requirements equals the total number of Contestants MotorCity Casino Hotel has decided may participate in the Hot Dog Eating Contest (which number will not exceed twenty). Once all of the Contestant positions have been filled, the Contest Representative will inform the Contestants of the time and location within Sound Board where the Hot Dog Eating Contest will take place (the "Contest Area"). The Contest Representative will be entitled to resolve, in his/her sole discretion, any disputes that arise with respect to the Qualifying Game, and the decision of the Contest Representative will be final and binding.

4. The Hot Dog Eating Contest:

- a. Each Contestant must arrive in the Contest Area (and notify the Contest Representative of his/her presence) at least fifteen (15) minutes prior to the scheduled start time of the Hot Dog Eating Contest (as communicated by the Contest Representative in accordance with these Rules), must sign the Required Documentation and deliver it to the designated MotorCity Casino Hotel personnel, and must comply with such additional requirements for participation in the Contest as are set forth in these Rules or otherwise imposed by MotorCity Casino Hotel in its sole discretion. MotorCity Casino Hotel reserves the right, in its sole discretion, at any time, to request to see a Contestant's Government ID and/or to conduct such other verification process as it deems necessary to confirm the identity and eligibility of any individual participating in the Contest (collectively, the "Verification Process"). Good faith efforts will be made to complete the Verification Process in as timely a manner as reasonably possible. If MotorCity Casino Hotel, in its sole discretion, is dissatisfied with the results of any Verification Process or concludes that a Contestant has failed to comply with any requirement, MotorCity Casino Hotel may, in its sole discretion, disqualify that individual from participating in the Contest, in which case all rights associated with such participation, including any right to be a Contestant and receive a Prize (as defined below), will be deemed forfeited.
 - b. If any Contestant is disqualified, at any time, for any reason, MotorCity Casino Hotel shall have no obligation to fill that Contestant's position for the Hot Dog Eating Contest, but reserves the right, in its sole discretion, to do so using a Qualifying Game methodology similar to that described above. No Contestant may select a substitute or stand-in to participate in the Hot Dog Eating Contest on his/her behalf or in his/her stead.
 - c. After the initial Verification Process, if any, has been completed, and provided the Contestant has not been disqualified, the Contest Representative will direct the Contestant to a table located in the Contest Area. The Contestant must remain at that table until completion of the Hot Dog Eating Contest. Prior to the commencement of the Hot Dog Eating Contest, each Contestant will be given the Hot Dogs he/she will be entitled to consume during the Contest; the Contestants will each be given the same number of Hot Dogs (which number will be determined by MotorCity Casino Hotel in its sole discretion but will not exceed twenty). For purposes of these Rules, "Hot Dog" means the entire sausage, bun, and all toppings and condiments thereon. Each Contestant will also be provided with water to drink during the Hot Dog Eating Contest; no other beverages (alcoholic or otherwise) or other items may be consumed during the Hot Dog Eating Contest. The Contest Representative will signal the start of the Hot Dog Eating Contest and thereafter the Contestants will have fifteen (15)

minutes (the "Contest Period") to attempt to completely consume (without the use of any utensils) as many of his/her Hot Dogs as possible, while either sitting or standing at his/her assigned table. Contestants must completely swallow each Hot Dog before attempting to consume the next one. The Contest Representative will give a warning signal when fifteen (15) seconds remain in the Contest Period. At the end of the Contest Period, the Contest Representative will signal the completion of the Hot Dog Eating Contest and, at that time, each Contestant must immediately cease chewing, and must immediately swallow or spit out (which will not be considered vomiting or regurgitation for purposes of these Rules) any Hot Dog still remaining in whole or part in his/her mouth. MotorCity Casino Hotel reserves the right to disqualify from further participation in the Contest any Contestant who fails to comply with that requirement or who places all or any part of a Hot Dog in his/her mouth after the Contest Period ends. Following completion of the Contest Period, the Contest Representative will count, tally, and record the total number of Hot Dogs that each Contestant completely consumed in accordance with these Rules (only those Hot Dogs that were completely consumed, with no portion remaining un-swallowed, will be counted toward a Contestant's total number of consumed Hot Dogs). The Contestant who completely consumed the greatest number of Hot Dogs within the Contest Period and in accordance with these Rules will be deemed the "Winning Contestant" unless two or more Contestants are tied (based on their consumption of an identical number of Hot Dogs); in that case, the tied Contestants will compete in a tie-breaking session utilizing the Rules used for the initial Hot Dog Eating Contest session, except that the tied Contestants will each be given only one (1) Hot Dog and the first Contestant to completely consume that Hot Dog in accordance with these Rules will be deemed the Winning Contestant (unless a tie again occurs, in which case the process described above will be repeated until the tie is broken).

- d. The Contest Representative will be entitled to resolve, in his/her sole discretion, any disputes that arise with respect to the Hot Dog Eating Contest, including without limitation any disputes regarding the rightful winner of the Grand Prize and each Participation Prize (each as defined below). The decision of the Contest Representative will be final and binding on all Contestants. The Winning Contestant shall be the one and only winner of the Grand Prize; no other Contestants will be eligible to win the Grand Prize.
- e. The Winning Contestant will be awarded the "Grand Prize" of \$1,000.00 in cash, subject to and in accordance with these Rules. All other Contestants who completed the Hot Dog Eating Contest without disqualification will be awarded a "Participation Prize" of \$100.00 in cash, subject to and in accordance with these Rules (the Grand Prize and Participation Prizes being referred to herein collectively as the "Prizes"). The Contest Representative will award and distribute the Prizes to the Contestants immediately following the Hot Dog Eating Contest in such manner as he/she deems appropriate in his/her sole discretion. If a Contestant does not claim his/her Prize in person at that time and in compliance with these Rules (including, without limitation, by completing all paperwork required by MotorCity Casino Hotel and presenting his/her Government ID upon request), MotorCity Casino Hotel will be entitled to disqualify that individual from participation in the Contest, in which case the Contestant will be deemed to have forfeited the applicable Prize and MotorCity Casino Hotel will have no obligation to award it. No Contestant will be eligible to win more than one (1) Prize. Prizes are non-transferable and may not be claimed by, and will not be distributed to, anyone other than the Contestant who won the applicable Prize.
- f. In addition to any other grounds for disqualification set forth in these Rules, the following conduct is prohibited in connection with the Qualifying Game and the Hot Dog Eating Contest, and MotorCity Casino Hotel will be entitled to disqualify from participation in the Contest any individual who engages in any such conduct (as determined by MotorCity Casino Hotel personnel in their sole discretion):
 - i. Delaying any portion of the Contest, in any way, for any reason.

- ii. Failing to timely sign the Required Documentation and deliver it to the designated MotorCity Casino Hotel personnel.
- iii. Touching and/or consuming in whole or part any of his/her Hot Dogs prior to the commencement of any Contest Period or any tie-breaking session in which he/she is a participant, or following completion of same.
- iv. Leaving his/her designated area prior to or during the Contest Period or any tie-breaking session in which he/she is a participant.
- v. Making physical contact (deliberately or otherwise) with any other Contestant at any time prior to or during the Contest Period or any tie-breaking session in which he/she is a participant or while any other portion of the Contest is being conducted, including without limitation, during the tallying of consumed Hot Dogs.
- vi. Vomiting or regurgitating at any time during the Contest Period, any tie-breaking session in which he/she is a participant, or during the tallying of consumed Hot Dogs.
- vii. Using a utensil to eat a Hot Dog.
- viii. Failing to completely consume a Hot Dog prior to beginning to consume another one.
- ix. Appearing to be visibly sick or under the influence of any drug or intoxicant during the Contest Period, any tie-breaking session in which he/she is a participant, or during the tallying of consumed Hot Dogs.

In the event of disqualification for any of the foregoing reasons or as otherwise permitted under these Rules, the individual will be barred from further participation in the Contest and will forfeit any right to receive a Prize or any other benefit associated with such participation

- 5. Residents of states of the United States and provinces of Canada that prohibit participation in contests of this nature are not eligible to participate in this Contest. Additionally, individuals who have: been banned from MotorCity Casino Hotel; have elected to self-exclude from MotorCity Casino Hotel or to become disassociated persons under Michigan law or to be placed on MotorCity Casino Hotel's list of self-excluded persons; or those who are otherwise barred from entry to MotorCity Casino Hotel's complex are ineligible to participate in the Contest and will be deemed to have forfeited any Prize won. The following persons are also prohibited from participating and will be deemed to have forfeited any Prize won: MotorCity Casino Hotel associates and their immediate family members; members of the Michigan Gaming Control Board, its staff, state police gaming section employees and employees of the attorney general assigned to the casino control division; owners of MotorCity Casino Hotel; and, to the extent their participation is contrary to law, the immediate family members of the foregoing individuals. Immediate family means any of the following, whether by the whole or half blood, marriage, adoption or natural relationship or effect of law: spouse (other than a spouse who is legally separated from the individual under a decree of divorce or separate maintenance); each parent, father—in—law, mother—in—law, grandparent, sibling, dependent, child, and grandchild; and the spouse of each of the foregoing.
- 6. The Contest is subject to all applicable federal, state and local laws, rules, and regulations. All references to the value of any Prize are in U.S. funds. All times stated are local Detroit, Michigan times. All applicable taxes, fees and licenses are the responsibility of the Prize winner(s), who must pay all applicable taxes on any Prize won and must authorize the deduction of all applicable taxes on monetary Prizes.
- 7. MotorCity Casino Hotel reserves to itself the right to interpret these Rules and to resolve any dispute or situation not covered by these Rules in such manner as it deems fair and appropriate in its sole discretion, and each such decision shall be final and binding on all Potential Contestants and Contestants. To apprise MotorCity Casino Hotel of a dispute not resolved by the Contest Representative as otherwise permitted in these Rules, the Potential Contestant or Contestant must provide written notice in person or delivered by nationally recognized overnight courier service or certified U.S. mail to MotorCity Casino Hotel's Vice President of Compliance, at 2901 Grand River Ave., Detroit, Michigan 48201, within ten (10) days of the event giving rise to the dispute. The notice must include a detailed written description of the basis for the dispute.

- 8. These Rules shall be governed by and construed in accordance with the laws of the State of Michigan (exclusive of its Choice of Law provisions). MotorCity Casino Hotel and each Potential Contestant and Contestant agree that any unresolved matter arising out of or relating to these Rules or the Contest that would otherwise be subject to litigation in a court of competent jurisdiction or subject to the jurisdiction of a regulatory agency will be submitted, instead, to the extent not contrary to law, to arbitration in accordance with the rules of and shall be administered by the American Arbitration Association, with the proceedings to be held in Detroit, Michigan, and, in the case of any appeal permitted under those rules, exclusive jurisdiction and venue will rest with the federal and state courts in the State of Michigan, County of Wayne. If any provision of these Rules is found to be invalid or unenforceable, such invalidity or unenforceability shall not invalidate or render unenforceable the balance of these Rules; instead, the balance of these Rules shall be construed as if not containing the particular invalid or unenforceable provision, and the rights and obligations of each Potential Contestant and Contestant and MotorCity Casino Hotel shall be construed and enforced accordingly. No Potential Contestant or Contestant shall have the right to assign or otherwise transfer his/her rights or obligations under these Rules or with respect to the Contest. No waiver by MotorCity Casino Hotel of any provision of these Rules shall be valid unless it is in writing and signed by MotorCity Casino Hotel. No waiver on any one occasion shall be deemed a waiver on any other occasion, nor shall the waiver of any one provision extend to any other provision.
- 9. MOTORCITY CASINO HOTEL IS NOT RESPONSIBLE FOR ANY ERRORS OR OMISSIONS IN ANY ADVERTISING FOR THE CONTEST, WHETHER ONLINE OR OTHERWISE. MOTORCITY CASINO HOTEL IS NOT RESPONSIBLE FOR ANY INCORRECT OR INACCURATE INFORMATION ABOUT THE CONTEST DISSEMINATED BY POTENTIAL CONTESTANTS, CONTESTANTS OR ANYONE ELSE, OR DUE TO EQUIPMENT, SYSTEM, OR PROGRAMMING ERROR OR MALFUNCTION.
- 10. Without limiting any other provision of these Rules, MotorCity Casino Hotel reserves the right in its sole discretion to change, cancel, suspend, or modify the Contest at any time, without notice, in the event that MotorCity Casino Hotel concludes the Contest is not capable of being conducted or continued as planned (e.g. due to any cause which MotorCity Casino Hotel in its sole discretion concludes affects the administration, security, fairness, integrity, or proper conduct of the Contest) or in the event that it is impractical to conduct or continue all or any part of the Contest as a result of construction activity or events beyond the control of MotorCity Casino Hotel (including, without limitation of the foregoing, acts of terrorism, civil commotion, war, fire, explosion, inclement weather or other Acts of God, power failure, labor unrest of any type, or road or traffic conditions).
- 11. By registering for or otherwise seeking to participate or actually participating in any way in the Qualifying Game or any other component of this Contest, each individual agrees to be bound by these Rules as amended, interpreted and applied by MotorCity Casino Hotel in its sole discretion. MotorCity Casino Hotel reserves the right to disqualify from participation in the Contest any individual who violates any of the Rules, or attempts in any way to defraud MotorCity Casino Hotel or any other individual, and anyone so disqualified will be deemed to have forfeited his/her right to a Prize and the individual(s) involved may be subject to civil liability and/or criminal prosecution. Furthermore, any violation of any applicable federal, state or local laws, rules, or regulations, any violation of another individual's or third party's rights or interests, any acts intended to interfere with or hinder the participation of any other individual, or any other conduct that MotorCity Casino Hotel deems in its sole discretion to be inappropriate may result in the Potential Contestant's or Contestant's disqualification and forfeiture of any right to a Prize and may subject the individuals involved to civil liability and/or criminal prosecution.
- 12. In addition to the Verification Process elsewhere in these Rules described, MotorCity Casino Hotel reserves the right in its sole discretion to subject an individual's eligibility to win a Prize in this Contest to a verification process. Good faith efforts will be made to complete that verification process as soon as reasonably possible. At the sole discretion of MotorCity Casino Hotel, an individual will not be deemed to be a "winner" of a Prize until that verification process has been completed and MotorCity Casino Hotel is

satisfied in its sole discretion that the Contestant is entitled under these Rules to the applicable Prize; if MotorCity Casino Hotel is not so satisfied, the Contestant will be deemed to have forfeited the applicable Prize. Each Contestant that wins a Prize must also, upon request, sign such documentation as MotorCity Casino Hotel requires with respect to accepting the Prize, including without limitation MotorCity Casino Hotel's Acceptance of Award form; anyone who fails to sign any such item upon request shall be deemed to have forfeited the applicable Prize.

As a condition of participation in the Contest, I represent, acknowledge and agree as follows:

I have read the terms of these Rules and understand them, consent to each of them, and agree to comply at all times with all of them. I understand the risks of participating in the Contest, including, without limitation, the health risks and associated risks inherent in eating contests and in the consumption of large quantities of food and calories (including, without limitation, choking, vomiting, feeling nauseous or dizzy, and any other risks not known or not reasonably foreseeable at the time of signing this document), and the risk of accident, injury, paralysis, disability, death, and/or damage to and/or loss of property. I also understand and agree that the Contest is an entertainment event and that, by participating in it, I may appear (and comments about me by others may be made) in a manner and/or with content that may be surprising, humiliating, embarrassing, derogatory, hostile, and/or otherwise offensive to me or to others. I expressly and voluntarily assume all of the risks associated with my participation in the Contest.

I am in good health and do not have any physical or mental condition, injury, limitation, allergy, or illness that could affect my ability to participate in this Contest and am thus able to participate in it without adverse health consequences. I hold a valid driver's license or government issued photo ID card, and I have not been placed on or requested placement on the list of disassociated persons maintained by the Michigan Gaming Control Board nor have I elected to be placed on MotorCity Casino Hotel's list of self-excluded persons nor have I been banned from MotorCity Casino Hotel nor am I otherwise barred from entry to MotorCity Casino Hotel. I am at least twenty-one (21) years of age and not otherwise prohibited by the Rules from participating in the Contest.

I hereby grant to MotorCity Casino Hotel and each of its parents, subsidiaries, members, management committee, and affiliates, and their respective officers, directors, employees, and agents (collectively, "Released Parties") the full, irrevocable and unlimited right, as part of MotorCity Casino Hotel's marketing, advertising, and promotional activities, and/or other purposes (i) to use my name, the name of the city in which I live, and any statement I write (the "Information"), (ii) to make audio and/or visual recordings of me, including without limitation of the foregoing, audio and/or visual recordings of my face, likeness, voice, appearance, actions, activities, and experiences in connection with the Contest (collectively, the "Recordings"), (iii) to make copies (collectively, the "Copies") of any or all of the foregoing, and (iv) to use, alter and reuse and/or make any derivative use of all or any part of the Information, Recordings, and/or the Copies for promotional, advertising, marketing, and/or other purposes, without limitation, perpetually and irrevocably, in all media, now known or hereafter derived, throughout the universe, and without payment. I acknowledge that no fees, royalties, residuals or other consideration will be payable to me for or in connection with my participation in the Contest or for or in connection with any use of any Information, Recordings, or Copies in any manner or media now known or hereafter invented.

I WAIVE ANY AND ALL RIGHTS AGAINST AND RELEASE, HOLD HARMLESS, AND TO THE FULLEST EXTENT PERMITTED BY LAW, INDEMNIFY AND DEFEND THE RELEASED PARTIES FROM ALL CLAIMS, CAUSES OF ACTION, DEMANDS, RESPONSIBILITY AND LIABILITY OF WHATEVER KIND OR NATURE, IN LAW OR EQUITY, WHICH ARISE OR MAY ARISE, NOW OR LATER, WHETHER OR NOT NOW KNOWN OR SUSPECTED, WHICH I, MY HEIRS, EXECUTORS, ADMINISTRATORS, PERSONAL REPRESENTATIVES, LEGAL SUCCESSORS AND/OR ASSIGNS NOW HAVE OR MAY HAVE AGAINST THE RELEASED PARTIES ARISING OUT OF OR IN ANY WAY CONNECTED WITH THE CONTEST AND/OR MY PARTICIPATION THEREIN, INCLUDING

WITHOUT LIMITATION, CLAIMS, CAUSES OF ACTION, DEMANDS, RESPONSIBILITY AND LIABILITY (INCLUSIVE OF MEDICAL COSTS, EXPENSES AND ATTORNEYS' FEES) INVOLVING ACCIDENT, INJURY, EMOTIONAL DISTRESS, PARALYSIS, DISABILITY, DEATH, DAMAGE TO OR LOSS OF PROPERTY, LIBEL, INVASION OF PRIVACY, AND/OR DEFAMATION, AND I FURTHER AGREE TO INDEMNIFY AND DEFEND THE RELEASED PARTIES FROM AND AGAINST ALL THIRD PARTY CLAIMS ARISING FROM FAILURE ON MY PART TO COMPLY WITH ANY OF THE RULES. I understand that, for purposes of this paragraph, the "Released Parties" specifically include Detroit Entertainment, L.L.C., Ilitch Holdings, Inc., Little Caesar Enterprises, Inc., Olympia Entertainment, Inc., and each of their related and affiliated companies, and in each case, their respective shareholders, members, officers, directors, management committees, employees, and agents, and also the officials, judges, sponsors, advertisers, Contest Representatives and event hosts for the Contest. I understand that this document exempts, waives and releases the Released Parties from all liability for personal injury, property damage, and wrongful death, including but not limited to, that caused by negligence, including the negligence, if any, of the Released Parties, and I further understand and agree that included within the scope of said exemption/waiver/release is any cause of action arising from or related to my consumption of any Hot Dog or portion thereof during the Contest that was prepared and/or provided by the Released Parties, and/or the Released Parties' negligent supervision or instruction during the Contest.

I understand and agree that this document is intended to be as broad and inclusive as permitted by the laws of the State of Michigan, and that it is governed by and interpreted in accordance with the laws of the State of Michigan. I also agree that if any clause or provision of this document, inclusive of any release contained in it, is held invalid or unenforceable by a court of competent jurisdiction, such invalidity or unenforceability shall not otherwise affect the remaining provisions of this document, which shall continue to be enforceable.
